(In pursuance to power conferred upon Officer on special duty by the Fee Regulatory Committee (Technical) wide its resolution dated 4^{th} January, 2018, the following circular is issued accordingly.)

CIRCULAR:

For institutions/courses started in the academic year 2017-18 **OR** reinstated in 2017-18 **OR** not submitted the fee proposal due to valid reasons, the Committee, after examining the merits of the proposal, determines the fee structure for the year **2017-18** only as per the Appendix attached herewith.

The fee determined by the committee is applicable to a student who is admitted in that academic year and shall continue to apply till completion of his or her course in the same institution. The difference between the provisional fee charged by the institution and the fee determined by the committee shall have to be paid by the student if the fee determined is higher than the provisional fee charged by the institution and paid by the student **OR** the institution will have to refund the difference to the student if the provisional fee charged by it, is higher than the fee determined by the committee. The institution shall not charge or collect any fee other than the fee determined by the committee. It is also not allowed to collect the fee at a time amounting to more than one term fee from a student in an academic year.

However, for the fee determination of subsequent years i.e. 2018-19 and 2019-20 of the present fee block, the institutions shall have to submit proposal along with detail audited financial data for the Financial Year 2017-18 latest by **01.06.2018** in prescribed format for further necessary process at committee level.
