### CIRCULAR:

For determination of fee structure for the block period starting from 2014-15 to 2016-17, following self-financed institutions conducting various professional courses had either not submitted their online fee proposals within the stipulated time limit or the submitted proposal was not as per the requirement. After repeated communications, they have submitted fee proposals to the Committee. The Committee after due deliberation decided that since the institutions have not submitted fee proposals during the fee determination process carried out by the Committee for year 2014-15 to 2016-17, the existing fees approved by the Committee for respective institution shall apply for the year 2014-15 also, which is as per **Appendix-I**

The fee approved by the Committee is applicable to a student who is admitted in the academic year 2014-15 and shall continue till completion of his course. The difference in the fees, if any, shall have to be either paid by the candidate to the institute or refunded by the institute to the candidates, as the case may be. The institute is not allowed to charge or collect any fee other than the fees determined by the Committee and not allowed to collect the fee at a time amounting to more than one term fee from a student in an academic year.

For the year 2015-16 and 2016-17 all these institutions have to submit fee proposal with audited accounts of 2014-15 to the Committee latest by 30.06.2015.

These institutions are also directed to submit documentary proof of fees collected from the students admitted in the year 2014-15 with fee receipt and notice issued by the institutions to students, latest by 30.04.2015 to the Committee.
