Sir/Mam,

This is for your kind notice that as per the provisions of the Gujarat Professional Technical Educational Colleges or Institutions (Regulation of Admissions and Fixation of Fees) Act, Gujarat Act No. 2 of 2008 ("the Act" for short), for all the institutions running self-financed programs in the state of Gujarat, which are notified as the professional technical programs under section 2(k) of the Act and its subsequent amendments, the fee is to be determined by the Fee Regulatory Committee (Technical) ("FRC-T" for Short). The list of professional technical programs is available on the Committee's website.

This letter is regarding the new institutions to be started in the year 2025-26 or those institutions which were started in the earlier years, but the institutions are going to start new programs from the year 2025-26 or those institutions which are added under the purview of Fee Regulatory Committee (Technical) from the year 2025-26 due to what so ever reasons. The Principals/Directors or concerned authorities of such institutions are informed to approach the FRC-T for the determination of the fees for the year 2025-26, along with their fee proposal and the hard copies of the documents mentioned below.

- 1. Forwarding letter (As per Annexure-1) on the letterhead of the sponsoring body/university/institution, duly attested by the head/principal of the institution.
- 2. Approval from Apex Authority and/or resolution from sponsoring body, resolving to start the program/institution and Letter of affiliation from the affiliating University (if applicable). In case of non-availability of the approval from Apex Authority/affiliation letter, the program/institution has to approach the Committee only after getting the required documents. The institutions are requested to refer to the FRC-T website regularly for the latest announcements.
- 3. In the case of the University, the certified copy of the resolution of the Governing Body/Board of Governance, resolving to start this program.
- 4. Affidavit in prescribed proforma (As per Annexure-2).
