As per the powers conferred upon the OSD by the Committee, the following circular is issued.

Circular:-

The institutions listed in Appendix-III to this circular had proposed to raise the fee structure upto 5% of the existing base notional fee for the year 2022-23 in Phase-1. However, the declaration-cum-undertakings submitted by them were not as per the formats prescribed by the Committee. In view of this, as per the decision taken by the Committee in its meeting dated 16-06-2023, the fee structures of these institutions were not declared and the institutions were informed vide the letters dated 20-06-2023 to submit fresh proposals along with prescribed declaration-cum-undertakings. In response to the Committee's above mentioned communication, the institutions have submitted the fresh proposals with necessary compliance. Accordingly, in continuation of the Fee order (Ref-1), the fee structures of the institutions are declared as per the Appendix-III to this circular. All the terms and conditions of the Fee order (Ref-1) will be applicable to all the institutions listed in Appendix-III.
