Sir/Mam,

This is for your kind notice that as per the provisions of the Guj. Act 2 of 2008, for all the institutions running self-financed programs in the state of Gujarat, which are notified as the professional technical programs under section 2(k) of the Act 2 of 2008 and its subsequent amendments, the fee is to be determined by the Fee Regulatory Committee (Technical). The list of professional technical programs is available on the committee's website www.frctech.ac.in/document/Circular_List.pdf

This letter is regarding the new institutions to be started in the year **2023-24** or those institutions which were started in the earlier years, but the institution is going to start new programs from the year **2023-24** or those institutions which are added under the purview of FRC (Technical) from the year **2023-24** due to what so ever reasons. The Principals/Directors or concerned authorities of such institutions are informed to approach the Fee Regulatory Committee (Technical) for the determination of the fees for the year 2023-24.

Please submit hard copies of the following documents along with your proposal: -


1. Forwarding letter on the letterhead of the sponsoring body/university/institution, duly attested by the head/principal of the institution, containing the name of Institution, Program, starting from the year **2023-24**, proposed fee structure, and name of Nodal officer along with his mobile number and email.

2. Approval from Apex Authority and/or resolution from Sponsoring body, resolving to start the program/institution and Letter of affiliation from the affiliating University (if applicable). In case of non-availability of the approval from Apex Authority/affiliation letter, the program/institution has to approach the Committee only after getting the required documents. The time limit for submission of proposals mentioned in point (3) of the circular Dated 21-04-2023 available on the website of the Committee will be extended accordingly for the institutions starting from the academic year 2023-24. The institutions are requested to refer to the FRC website regularly for the latest announcements.
3. In the case of the University, the certified copy of the resolution of Governing Body/Board of Governance, resolving to start this program.
4. Affidavit in prescribed proforma available on FRC website, duly sworn before Executive Magistrate/Notary Public.
5. Demand Draft for processing fee as mentioned below, in favour of **“Fee Regulatory Committee (Technical)”** and payable at **Ahmedabad**.
