Circular:-

To The Trusts/ Societies/ Section 25/ Section 8 companies / Private Universities/ State Universities (here after referred to as “Sponsoring Body” having Self-Financed Professional Technical Programs with in the State of Gujarat.

The Fee Regulatory Committee (Technical) is in the process of determination of fee structure for the professional programs covered under the Gujarat Professional Technical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees) Act, 2007, conducting on self-finance basis in Gujarat State for the students to be admitted in the academic year 2017-18, 2018-19 & 2019-20.

It is mandatory for every self-financed institution in Gujarat State, which conduct any of the following courses, to get their fees determined by the Fee Regulatory Committee (Technical).

1. Bachelor of Engineering and Technology and the Diploma in Engineering (including integrated diploma-degree program).
2. Bachelor of Pharmacy and the Diploma in Pharmacy.
3. Bachelor of Architecture and the Diploma in Architecture.
4. Bachelor of Hotel and Tourism Management and the Diploma in Hotel and Tourism Management.
5. Master of Business Administration
6. Master of Computer Application
7. Master of Engineering or Technology
8. Master of Pharmacy
9. Bachelor of Planning
10. Master of Planning.
11. Bachelor of Architecture and Interior Design.

The Committee decided to invite fee proposals through online submission on web portal. All the self-financed institutions and its “Sponsoring Body” required to submit the proposal through the portal only as and when announced by the committee.

Therefore, the provisional list and details of “Sponsoring Body” having Self-Financed Professional Technical Programs in the state of Gujarat, as available with this office and gathered from other sources, are uploaded on website www.frctech.ac.in.

All the "Sponsoring Body" having Self-Financed Professional Technical Programs in the state of Gujarat are requested to verify their details. If any discrepancy/mistake or missing details noticed in it, kindly intimate to the Committee ONLY on email ID: **frctechfee1720@gmail.com** immediately but not later than **30th December, 2016** as per format provided hereunder along with request letter and supporting documents.

Any "Sponsoring Body" conducts any of the above programs and their name is not included in the provisional list are informed to approach personally to the Fee Regulatory Committee latest by **30th December, 2016** along with request letter and supporting documents for determination of fee structure for block year 2017-18 to 2019-2020.

Any institution or management found to be collecting fees in contravention to the said Act shall be liable for punishment under section 14 of the Act. The Committee shall be constrained to take stringent action against such institutions.
